**Descriptive Information :** Ford's team reviewed supplier process and maintenance records to determine the population of affected parts. The Ford process is capable of tracing front passenger knee airbag production to the vehicle in which the front passenger knee airbag is installed.

Affected vehicles are equipped with suspect front passenger knee airbags.

## Description of Defect :

**Description of the Defect :** Affected vehicles were built with a front passenger knee airbag that may have been produced with insufficient welds. An insufficient weld can cause loss of airbag integrity and result in an improper airbag deployment.

**FMVSS 1 :** NR

**FMVSS 2 :** NR

**Description of the Safety Risk :** If the front passenger knee airbag integrity is compromised, it may not provide design intent occupant knee restraint during a deployment, increasing the risk of injury during a crash event that necessitates front passenger knee airbag deployment.

Description of the Cause : Front passenger knee airbag supplier did not adjust welding parameters correctly after a tool changeover.

## Description of Remedy :

Description of Remedy Program : Owners will be notified by mail and instructed to take their vehicle to a Ford or Lincoln dealer to have the front passenger knee airbag replaced. There will be no charge for this service.

Ford provided the general reimbursement plan for the cost of remedies paid for by vehicle owners prior to notification of a safety recall in May 2021. The ending date for reimbursement eligibility is March 21, 2022.

Ford will forward a copy of the notification letters to dealers to the agency when available.

How Remedy Component Differs : The recalled front passenger knee airbags (KR3B-63060T10-BJW) will be

from Recalled Component : replaced with front passenger knee airbags that meet weld strength specifications.

Identify How/When Recall Condition was Corrected in Production : On August 24, 2021, Faurecia reset weld process parameters and conducted weld testing to confirm proper weld strength.

Description of Recall Schedule : Notification to dealers is expected to occur on February 17, 2022. Mailing of owner notification letters is expected to begin March 7, 2022 and is expected to be completed by March 11, 2022.
