Description of the Safety Risk: The absence of the brake fluid warning statement on the reservoir cover may

lead to an improper maintenance procedure if the owner does not have access to or does not consult the owners' manual (which contains the brake fluid specifications). Improper brake system maintenance could, over time,

affect brake system performance and increase the risk of a crash.

Description of the Cause: Brake Master Cylinder DOT4 Decal (P/N 44791-07) may contain a non-uniform

edge which may prevent the decal from permanently adhering to the cover

surface.

Chronology:

02/03/2022 - Harley-Davidson's Technical Subcommittee (TSC) was made aware of a potential issue with MY22 XL (all models) built at York Vehicle Operations. An audit performed on 01/28/2022 revealed that the brake fluid warning decal, part number 44791-07 (DECAL, FRT MSTR CYL/DOT 4), was missing from the front brake master cylinder cap on one of the vehicles inspected during the audit.

02/03/2022 - 02/28/2022 - The TSC conducted a root cause and scope analysis. This included an audit of vehicles as well as discussions with the supplier. The TSC's investigation indicated that due to a non-uniform edge on the decal, the brake fluid warning statement on some of these vehicles may not be permanently affixed.

03/03/2022 – The Field Action Committee (FAC) reviewed the TSC's findings and analysis and escalated the matter to H-D's Executive Decision Authority (EDA).

03/08/2022 – Based upon the information developed during the investigation, the EDA determined that this condition may constitute a noncompliance with FMVSS 122, S5.1.9, and authorized a recall to address this condition. There have been no reports of any accidents or injuries related to this issue.

Description of Remedy:

Description of Remedy Program : Replacement decals will be mailed to owners of affected motorcycles with

instructions to inspect the decals on their motorcycle. Instructions on how to install replacement decals, if needed, will also be provided. Owners will also be given the option to arrange service with an authorized Harley-Davidson dealer, who will perform the remedy at no charge to the

customer. Pursuant to 49 CFR 577.11(e), Harley-Davidson requests that it be exempt from providing a notification of a reimbursement plan. Any pre-

notification product failure would have been addressed under the

manufacturer's limited warranty. Accordingly, no person would be eligible

for reimbursement pursuant to 573.13.
