#### **Description of Defect:**

Description of the Defect: Mercedes-Benz AG ("MBAG"), the manufacturer of Mercedes-Benz vehicles, has

determined that on certain Model Year ("MY") 2021-2022 Maybach S-Class (223 platform) vehicles, various trim parts on the seatbacks for both front

seats might not meet current production specifications.

Description of the Safety Risk: In the event of a crash with deployment of the rear airbags, trim parts on the

front seats might partially detach as the airbags unfold. As a consequence, the unfolding of the rear airbag cushion might be impaired, or the rear airbag cushion itself might become damaged increasing the risk of injury for rear

occupants.

Description of the Cause: Due to a deviation in the development process, certain trim parts on the front

seatbacks might not meet current production specifications.

## **Chronology:**

In the end of March 2021, MBAG launched initial investigations based on internal quality assurance analyses.

Tests were performed, which indicated that certain front seat trim parts might not meet specifications. At this point in time, indications were that only internal vehicles were affected.

In May 2021, optimized trim parts were introduced in the relevant production plant. In parallel, a plant action was implemented to rework all potentially affected vehicles, which were still within the control of MBAG. In August 2021, it was found that there were also potentially affected vehicles in the field. Subsequently, possible consequences as well as relevant regulatory requirements for vehicles in the field were analyzed. These intensive investigations were performed until December 2021 due to the complex nature of the issue. Four different trim parts with a large number of variants, which are procured from different suppliers, were part of these investigations. Comprehensive analyses were ongoing in order to understand this issue and the dependencies between the components and to clarify whether there exists a potential safety consequence. In January 2022, further analysis was conducted to identify the potentially affected vehicle population including vehicles that might have been equipped with a potentially affected spare part. .Tracking the flow of potentially affected spare parts in coordination with logistics and markets to identify affected vehicles in the field lasted until mid-March 2022. Mercedes-Benz AG is not aware of any related customer complaints.

On March 25, 2022, MBAG determined that a potential safety risk cannot be ruled out and decided to conduct a recall.

#### **Description of Remedy:**

Description of Remedy Program: An authorized Mercedes-Benz dealer will replace the respective trim parts on the affected vehicles to current production specifications.
