Description of the Cause : According to the manufacture, some of the brass components may have porosity, contamination, and carbon.

4/20/2022 - KZ is notified by Enerco of their recall. Investigation ensues regarding KZ's usage.

4/21/2022 - Enerco provides information regarding supplied product.

4/23/2022 - KZ confirms use of the fittings and continues investigation to determine affected units.

4/25/2022 - KZ holds a safety committee meeting and votes to issue a recall.

4/26/2022-5/19/2022 - KZ continues to review purchase orders and production data. Determines that a number of included VINs were not equipped with the defective fitting and reduces the total population. No warranty data, customer complaints or other data has been received.
