mirror on the potentially affected vehicles. Letters will be sent to owners explaining how to proceed to change the defective mirrors. This repair / change will be done free of charge (Labor and parts) for the customers.

In case customers already did the right rearview mirror repair or change before the safety recall was released, the customer can contact Prevost for

a reimbursement according to Prevost reimbursement plan.

How Remedy Component Differs When installed, defective right rearview mirrors can not provide a clear
