**Descriptive Information :** The Recall came to Life when Pacific Trailer sent us a letter stating they had a bad batch of couplers that were sent out to a group of manufacturers that had tack welds along the bottom of the coupler instead of full welds on the bottom of there normal couplers. From the time frame they gave us we identified 565 possible units that could have gotten a miss welded coupler. This range of possible units are from September of 2021 until December of 2021. All units effected by this are Bravo Trailers with different makes and models ( Heros, Scouts, Stars,

**Description of the Defect :** Part number CA-5400-o and CA- 500-B show incomplete welds on the bottom side of the coupler.

**Description of the Safety Risk :** The welds on the bottom side of the coupler could break causing possible disconnect with tow vehicle increasing the risk of a crash

**Description of the Cause :** NR

## Chronology :

Bravo trailers received notification from Pacific Trailer 3/16/22 from part vender Redneck Trailer Supply. After that Bravo began to identify what trailers could possibly be affected by the parts sent by Pacific trailer. On 6/22 Bravo has located and tracked down all vin numbers that could potentially have been affected by the coupler. Bravo has not had any complaints or failures ever stated to them by any customers. The coupler manufacture was the one that notified us saying " there could be a problem " as of 10/22 Bravo trailers has yet to have a coupler failure come back to them or be notified that any of our customers are seeing this concern. Bravo was directed by the manufacturer of the coupler that if a coupler has a failure we will replace the coupler for the customer.

## Description of Remedy :

Description of Remedy Program : Part number CA-5400-o and CA- 500-B show incomplete welds on the bottom side of the coupler. Pacific Trailer Products Inc. will pay for inspections and replacement of any defective couplers at no cost to ourselves or the customer. Bravo Trailers impacted by this recall are new and owner's costs associated with the remedy of this recall will be reimbursed according to Bravo Warranty. Owners of subject Bravo Trailers who may have remedied the recall circumstance prior to the issuance of safty recall by Bravo Trailers will also be rembursed by the Bravo Warranty.

How Remedy Component Differs from Recalled Component : The standardized coupler is fully welded on the under side of the coupler. The recalled product shows only spot welds on the under side.

**Recall Schedule :**

Description of Recall Schedule : Bravo Trailers received the recall notice from Pacific Trailer on 3/11/2022. From that start date we compiled a list of vin numbers that could of possibly received a coupler from Pacific trailer in their recall time frame. That list was then sent out to individual dealer reps to compile customer contact information. Bravo Trailers has already reached out to all there dealers in regards to gathering customer information. We are currently still waiting on contact names and address from dealers. Once received we will proceed with sending out our recall letter to our customers that fall under the time line.
