Description of the Defect :	The internal aluminum burner tubes connecting the gas valves to the cook top burners can fracture from excessive vibration or shock experienced through travel.
FMVSS 1 :	NR

Description of the Safety Risk :	The burner tube could crack resulting a leak of propane. If ignited the propane could result in a fire and/or explosion which could result in personal injury.
Description of the Cause :	Suburban Lab analysis of failed burner tubes indicate hardening of the aluminum burner tubes likely caused by repeated impact or excessive vibration.

9/24/2020 - Suburban was notified by an Escape RV customer of an issue with their SDS2 cooktop. 09/25/2020 - Suburban opens and investigation on the SDS2 cooktop.

11/11/2020 - Lab Analysis completed on failed cooktop burner tubes indicating hardening.

11/2020 - 8/2021 - Suburban communicates with Escape RV regarding the issue.

08/19/2021 - Suburban requests information on the usage of the SDS2 and the vehicle information the cooktops are installed in.
