A trailer was manufactured and sold in October 2021. Kaufman Trailers received a warranty call from the customer on May 27, 2022, stating the ramp track holder has broken, causing damage to his equipment. The customer volunteered to bring the ramp track holder for inspection to Kaufman Trailers the week of 6/6/22. The ramp track was inspected by Senior Management on 6/14/22. A decision was made immediately to submit a recall.

Description of Remedy:

Description of Remedy Program: Kaufman Trailers is compiling a customer list that might be affected by

this defect. They are also creating an instruction letter to be approved by NHTSA to send certified mail to these customers. Kaufman will instruct customers on how to reinforce and will work with a local manufacturing business to remedy the problem at Kaufman Trailers expense. Total repair

should take no more than 30 minutes to complete.

How Remedy Component Differs The recall letter will detail the differences. There isn't a defective
