RELATED DEFECT IS ASSOCIATED WITH THE BURNER CONTROL VALVE WHERE THE VALVE STEM IS LOCATED DIRECTLY BEHIND THE COOKING KNOB OF THE COOKTOPS. THERE IS A POTENTIAL FOR A GAS LEAK BEHIND THE CONTROL KNOB TO IGNITE AND CREATE A SMALL PILOT FLAME AND

PRESENT A POSSIBILITY OF A BURN TO THE USER.
