Description of the Defect : Separation of welded seam at the fabric to coach interface.

FMVSS 1 : NR

FMVSS 2 : NR

Description of the Safety Risk : In extreme cases the fabric could detach from the coach rail and remain attached to the awning frame. This could allow the awning to drop and extend beyond normal operation. This could result in personal injury, property damage, or a crash.

Description of the Cause : Insufficient weld penetration in some areas between the fabric and the adjoining PVC extruded track.

Identification of Any Warning that can Occur : A visible warning would include seeing a partial weld separation at the ends of the awning roll along the coach.

Description of Remedy Program : Remedy program will include providing instructions for inspection and repair or replacement as needed of awnings which do not pass the inspection or have an occurrence. If repair or replacement is needed we will supply the necessary items to complete the repair or or replace the faulty product. We will reimburse all OEM's, dealers, mobile repair companies and/or consumers for all costs associated with inspection, repair and/or replacement of the affected awnings.
