may not be legible.

Chronology:

On August 10, 2022, misprinted vehicle certification labels were discovered during quality audits at GM's assembly plant. The issue was submitted to GM's Speak Up For Safety (SUFS) program on August 24, 2022, and GM opened a formal investigation on September 2, 2022. GM's investigation determined that 30 vehicles may contain tire labels with the printing error. Of these, 24 are known to be in the U.S. On September 15, 2022, GM's Safety Field Action Decision Authority (SFADA) decided to conduct a noncompliance recall.

Description of Remedy:

Description of Remedy Program : Dealers will replace the vehicle certification label on the driver's side B-

pillar.

Pursuant to 49 C.F.R. § 573.13(d)(1), all covered vehicles are under

warranty, so reimbursement is not offered.

How Remedy Component Differs All information required by FMVSS 110 is legible on replacement
