to shift the transmission which could increase the risk of a crash.

On, or before, 10/7/2022 Shyft acknowledged two customer complaints involving the condition where the shifter could not shift into gear due to melting. On 10/7/2022 Shyft made the determination that a safety related defect could exists in the affected units. However, Shyft later learned that these vehicles are likely still in our possession and this recall was filed in an over abundance of caution. Vehicles subject to this recall were still in our possession and were remedied prior to release.

Description of Remedy:

Description of Remedy Program: For vehicles subject to this recall, they will be inspected to ensure the

transmission shifter cable is secured away from the exhaust manifold. All vehicles subject to this recall are within their respective warranty period and any failures would have been covered under the vehicle's warranty.
