Regulatory Non-Compliance Recall Campaign 0633
Harley-Davidson® Detachable Tour-Pak Luggage Carrier Conversion Kits

Dear Dealer:

Harley-Davidson Motor Company, Inc. has learned that certain Harley-Davidson® Detachable Tour-Pak Luggage Carrier Conversion Kits shipped to Harley-Davidson dealers between 1/19/2021 and 7/15/2022, Part Numbers 53000916 and 53000917 (the “Tour-Pak Kits”), may not conform to Federal Motor Vehicle Safety Standard/Canadian Motor Vehicle Safety Standard No. 108, *Lamps, reflective devices, and associated equipment*, if installed on Model Year 2014 - 2022 Touring and CVO Touring motorcycles. If the Tour-Pak Kit is installed and the Tour-Pak is subsequently removed, the green turn signal indicators in the instrument panel will “fast flash”, regardless of whether the turn signal lamps are functioning properly. This may cause the vehicle to fail to meet regulations that require a turn signal lamp failure to be indicated “by a ‘steady on,’ ‘steady off,’ or by a significant change in flashing rate.”

We have voluntarily declared that this condition constitutes a regulatory non-compliance to allow us to formally recall (Campaign 0633) all affected motorcycles/Tour-Pak Kits. The remedy is to first confirm that the Tour-Pak Kits installed on the motorcycles are covered by this recall. If covered, perform the recommended recall update per Service Bulletin M1561 (the “Bulletin”) to update the wiring harness in the Tour-Pak Kit. The Bulletin outlines the repair and credit procedures for the recall repair and additional relevant information.

In the interest of the safety of our mutual customers and as required by law, you may sell but **NOT DELIVER** any motorcycles listed in the *Fitment Statement* below equipped with the affected Tour-Pak Kits or deliver any over the counter Tour-Pak Kits until the remedy is completed per the service bulletin. **Please refer to *H-Dnet / My Toolbox / Warranty Campaign Center*. Select “Safety Campaign Open VIN list,” then select “0633” Campaign to view the VIN list.**

In accordance with federal regulations administered by the National Highway Traffic Safety Administration (NHTSA) and other appropriate market-specific government agencies, Harley-Davidson or authorized Harley-Davidson dealers will provide notice to all owners of record of affected products with direction to arrange for the recall service.

Fitment Statement: This recall covers Tour-Pak Kits that were dealer-installed or customer-installed accessories on Model Year 2014 through 2022 FLHTCU, FLHTCUL, FLHTK, FLHTK ANV, FLHTKL, FLHTKSE, FLHTKSE ANV, FLTRK, FLTRKSE, FLTRU, and FLTRUSE models. *Exception:* Models equipped with CB antenna are not subject to this recall.

Key Dates:

- On or about 8/15/2022: Service Bulletin posts.
- On or about 08/15/2022: Owner notification letters begin mailing.
- On or about 10/01/2022: Recall kits will be available to order.
