This is to notify you of a pending Recall Campaign to check the brake fluid reservoir mounting on approximately <u>28,732</u> MY16-22 Mercedes-Benz Metris vans. The recall campaign will be visible on the <u>www.safercar.gov</u> website and may generate questions from customers. All affected VINs will be flagged as "PENDING" in VMI and cannot be sold.		
Background		
Issue	Mercedes-Benz AG ("MBAG"), the manufacturer of Mercedes-Benz vans, has determined that on certain Model Year 2016 – 2021 Mercedes-Benz VS20 Metris vehicles (platform 447), the brake fluid reservoir might have been incorrectly mounted. As a consequence, the brake fluid reservoir could possibly detach from its mounting, potentially causing the reservoir to leak. A deterioration of braking performance due to loss of brake fluid cannot be ruled out which could increase the risk of a crash.	
What We're Doing	Yre Doing MBUSA is conducting a voluntary recall. An authorized Mercedes-Benz Metris dealer will check the brake fluid reservoir for proper mounting and ensure the correct installation.
