This causes wear on the bearings and, as a result, the turbine wheel of the turbocharger may contact the housing, or the turbocharger shaft can break. This could lead to a lack of power or even stalling, which could increase the risk of a crash.				
Precautions	A defect on the turbochargers and boost pressure system can lead to different warning messages such as the EPC, MIL, or oil warning light being displayed. In addition, the customer may notice indications like extended cranking, rough idling or lack of power. Owners experiencing these conditions are advised to contact an authorized Audi dealer to have the vehicle diagnosed/repaired.
