Dear Heartland RV Valued Dealer:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act. Heartland RV (Heartland) has decided that a defect which relates to motor vehicle safety exists in certain 2022 Heartland Big County, Big Horn, Big Horn Traveler, ElkrIDGE, Cyclone, Fuel, Gravity, Landmark, Milestone, Road Warrior, Torque Fifth Wheels and North Trail, Sundance, Torque, Fuel, Trail Runner, Pioneer, Prowler, Lithium Travel Trailers manufactured between 2021 and 2022. We apologize for any inconvenience this action may cause you, however your safety and continued satisfaction are of the utmost importance to us.

Reason for this recall

On certain 2022 Heartland Big County, Big Horn, Big Horn Traveler, ElkrIDGE, Cyclone, Fuel, Gravity, Landmark, Milestone, Road Warrior, Torque Fifth Wheels and North Trail, Sundance, Torque, Fuel, Trail Runner, Pioneer, Prowler, Lithium Travel Trailers the LP quick disconnect may have cracks in the brass that can lead to LP gas leaks. Excessive LP gas leak may lead to an explosion and fire, which may lead to property damage and personal injury.

Instructions for the repair and a list of the affected coaches with their VIN #'s can be found on the warranty portal. Please have the VIN #'s of the affected travel trailers available when you call.

Federal regulations require that any vehicle lessor receiving this recall notice must forward a copy of this notice to the lessee within ten days.

Note: It is a violation of federal law (CFR 49 Part 573.11&12) for a dealer to deliver a new vehicle that has been sold prior to completing this recall. Please be sure to address any vehicles in your inventory that are affected by this recall action.
