



New Safety Recall Advanced Communication – Z50

FCA US LLC (FCA US) has announced a safety recall on certain 2021 and 2022 Model Year (WL) Jeep® Grand Cherokee vehicles.

VINs identified as being involved in this campaign are currently live and searchable.
Stop sale is in effect for the above-identified vehicles.

Vehicles impacted by a stop sale are eligible for reimbursement allowance through the Recall Floorplan Reimbursement Policy (RFPRP), which can be requested upon recall claim submission.

IMPORTANT: Some of the involved vehicles may be in dealer new vehicle inventory. Federal law requires you to complete this recall service on these vehicles before retail delivery. Violation of this requirement by a dealer could result in a civil penalty of up to \$21,000 per vehicle. Involved vehicles can be determined by using the VIP inquiry process.

REASON FOR THIS SAFETY RECALL

Some of the above vehicles may have been built with a damaged taillamp/side marker that may be nonfunctional. Inoperative taillamp/side markers may cause an approaching vehicle to be unaware of the position and dimensions of the vehicle, which can cause a crash without prior warning.

The condition described above does not comply with Federal Motor Vehicle Safety Standard (FMVSS) No. 108 requires each vehicle to be equipped with at least two red steady burning taillamp-side markers.

SERVICE ACTION

FCA US will conduct a voluntary safety recall to inspect and replace both body mounted tail lamp assemblies as needed. Dealers will be notified of the launch of this safety recall by way of established communication methods. This recall is estimated to launch in **4th Quarter** of 2022.

We ask that you please take the time to ensure that your personnel are aware of this communication and are prepared to execute a customer friendly process for inquiries regarding involved vehicles.

Taillamps

Dear [Name],

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

FCA US LLC has decided that certain [2021-2022 Model Year (WL) Jeep Grand Cherokee] vehicles fail to conform to Federal Motor Vehicle Safety Standard (FMVSS) No. 108 requires each vehicle to be equipped with at least two red steady burning taillamp-side markers.

WHY DOES MY VEHICLE NEED REPAIRS?

The taillamp/side marker on your vehicle ^[1] may have been built with a damaged taillamp/side marker that may be nonfunctional. Inoperative taillamp/side markers may cause an approaching vehicle to be unaware of the position and dimensions of the vehicle, which can cause a crash without prior warning.

HOW DO I RESOLVE THIS IMPORTANT SAFETY ISSUE?

The remedy for this condition is not currently available. We are making every effort to finalize the remedy, and will service your vehicle free of charge (parts and labor) when the remedy is available.

FCA US will contact you again, by mail, with a follow-up recall notice when the remedy is available. Once you receive your follow-up notice, simply contact your Chrysler, Jeep®, Dodge or RAM dealer right away to schedule a service appointment ^[2]. Additional options for your next steps are included on the left side of this notification. We appreciate your patience.

WHAT IF I ALREADY PAID TO HAVE THIS REPAIR COMPLETED?

If you have already experienced this specific condition and have paid to have it repaired, you may visit www.fcarecallreimbursement.com to submit your reimbursement request online ^[3]. Once we receive and verify the required documents, reimbursement will be sent to you within 60 days. If you have had previous repairs performed and/or already received reimbursement, you may still need to have the recall repair performed.
