Forest River has decided that a safety defect exists in many 2022-2023 Forest River and Coachmen Travel Trailer, Fifth Wheel and Motorhome recreational vehicles. Forest River is recalling the defect model(s) to ensure the safety of our future retail consumers and your dealership. Forest River apologizes for any inconvenience this action may cause your dealership; however, safety continued satisfaction and our commitment to building great products are of the utmost importance to Forest River.

DEFECT/NONCOMPLIANCE:

"Per Details of Lippert Recall 22E-055: There may be insufficient weld penetration in some areas between the fabric and the adjoining PVC extruded track. In cases of insufficient welding this can allow the welded seam at the fabric to coach interface to separate, and depending on the amount of separation, could allow the awning to unroll whether retracted or extended.

EVALUATION OF RISK:

In extreme cases the fabric could detach from the coach rail and remain attached to the awning. This could cause the awning to drop and extend beyond normal operation. This could cause injury or a crash.

SERVICE PROCEDURE:

<u>Dealers:</u> it is not necessary to contact Lippert for Prior Authorization. Please follow the procedures listed below and on Dealer Connect. A Claim will need to be filed through Dealer Connect with clear photos of the awning tag and photos for the inspection, as well as of any issues if repairs or replacement is needed.

Pictures of the remedy are a condition of payment in which must be provided with a claim against the repair code(s).

<u>Parts:</u> You may contact your Forest River representatives or Lippert Components to place the order if a replacement fabric is needed. Please reference the remedy instructions for part listings.

Notice:

In no manner shall a Forest River Product Owner or Coachmen Product Owner be charged any fee(s) for scheduling, conduction or completion of the recall. Additionally, all dealership(s) that are Forest River and/or Coachmen dealership(s) are Federally Mandated to perform the recall once presented with this recall whether by the Owner or Dealership receipt of this letter, without denial of service to the Owner. Lastly, denial of a remedy for this recall is a Federal Violation punishable by law resulting substantial fines and/or civil penalties.

Federal Regulation requires that any lessor receiving this Recall must forward a copy of this notice to the lessee within ten days. If your dealership no longer owns this vehicle, please inform the Warranty Manager of the product listed above of the change of ownership.
