Issue:	The driver's frontal air bag inflator may explode due to propellant degradation occurring after long-term exposure to high absolute humidity, high temperatures, and high temperature cycling. An inflator explosion may result in sharp metal fragments striking the driver or other occupants, resulting in serious injury or death.					
Repair:	REPAIR AVAILABLE – October 24, 2023 - Replace driver's frontal airbag
