SUBJECT: Model GLE/ML and GLE Coupe (166 and 292 platform) Model Year 2012-2019

Check for Water entry in the Spare Wheel Well

Mercedes-Benz AG ("MBAG"), the manufacturer of Mercedes-Benz vehicles, has determined that on certain Model Year ("MY") 2012-2019 GLE/ML (166 platform) and GLE Coupe (292 platform) vehicles, water might intrude into the rear area of the vehicle and, over time, accumulate in the spare wheel well. In certain driving situations, and depending on the amount of water that has entered the spare wheel well, the accumulated water could intermittently contact the fuel pump control unit. Consequently, the fuel supply to the engine could be interrupted, which would lead to a loss of propulsion without warning. In such circumstances, the risk of a crash could be increased. Before the issue occurs, the driver may be made aware of water infiltration due to a damp carpet in the rear of the vehicle or the sound of water sloshing in the spare tire wheel well. In some cases, the driver could also be alerted to the condition by illumination of the check engine light in the instrument cluster. An authorized Mercedes-Benz dealer will install a water drain plug in the spare wheel well on the affected vehicles, check for water infiltration into the spare wheel well well well, and replace the fuel pump control unit, if necessary.

Prior to performing this Campaign:

- VMI must always be checked before performing campaigns to verify that the campaign is required on a specific vehicle. Always check for any other open campaigns, and perform accordingly.
- Please review the entire Campaign bulletin and follow the repair procedure exactly as described.

Approximately 348,183 vehicles are affected.

### Check spare wheel well and retrofit water drain grommet; replace fuel system control unit if necessary

## Check/test procedure 1

- 1. Open trunk.
- 2. Lift spare wheel well cover and secure it from falling down.
- 3. In vehicles with spare tire option code 690, remove spare tire and cover (Figure 1).



4. In hybrid model 166.063, remove load compartment shelf (A, Figure 2) with vehicle tool kit.

i For basic data, see AR68.80-P-5800GQA.

Load compartment floor (**B**, **Figure 2**) does **not** need to be removed (just folded up).

Lift left rear felt insert (C, Figure 3) and check for humidity or water deposits in marked area (D, Figure 3).
 There is no felt trim in hybrid model 166.063.



- a. If humidity or water deposits are *not* present in area (D, Figure 3): Carry out work procedure A.
- b. If humidity or water deposits are present in area (D, Figure 3): Carry out check/test procedure 2.

## Check/test procedure 2

i Only required if humidity or water deposits are detected in checked area (D, Figure 3).

- In hybrid model 166.063, remove the high-voltage battery.
  For basic data, see AR54.10-P-1140GQA.
- 2. Lift right front felt insert (E, Figure 4).
  - i Remove tool insert first.
  - **i** Not required for hybrid model 166.063.

3. Check the area around the fuel system control unit for humidity or water deposits (E, Figure 5).

- a. If humidity or residual water are *not* present in area (E, Figures 4 and 5): Carry out work procedure A and install remaining parts.
- b. If humidity or residual water are present in area (E, Figures 4 and 5): Carry out work procedures A and B.

# Work procedure A

 $\fbox{i}$  Work procedure A is always carried out.

Retrofit new water drain grommet (F, Figure 6).




Figure 7, shown on hybrid model 166.063

 I First, remove existing closed grommet (G, Figures 6 and 7).


