**NHTSA Recall No. 22V-038 - ORIGINAL NOTICE WAS MAILED ON FEBRUARY 21, 2022.**

Dear Grand Design RV Owner:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Grand Design RV has decided that a defect which relates to motor vehicle safety exists in certain 2013-2021 Solitude, Momentum, and Reflection recreational vehicles.

**! IMPORTANT !**

- Your vehicle falls within the recall population.
- You should immediately schedule an appointment with your dealer to have your vehicle inspected and, if necessary, repaired.

**Why is a recall being conducted?**

On select **2013-2021 Solitude, Momentum and Reflection Fifth Wheel & Travel Trailers, manufactured between January 1, 2013, and June 3, 2021, with LP gas refrigerators**, a 110-Volt wire located in the refrigerator cabinet may detach over time from its retainer. If this were to occur, the potential exists for the wire to contact the cooling unit of the refrigerator. Heat from the cooling unit could melt through the wire insulation and expose the copper wire. The exposed copper wire could then contact the refrigerator cooling unit causing an electrical arc that may burn through the cooling unit tube, creating the potential for a fire.

**What are we doing about the problem?**

On affected vehicles, Grand Design is authorizing additional securement to the 110-Volt wire to prevent contact with the refrigerator cooling unit burner tubes. Any damaged wires will be repaired and receive additional securement. Grand Design dealers have been notified of this recall and have the required repair instructions available. Repair time is estimated to take no more than 2.5 hours. There will be no charge for this service through your Grand Design dealership.

**What should you do?**

Please contact your selling or nearest Grand Design RV dealer as soon as possible to schedule an appointment. If your distance from a Grand Design dealer is significant, please contact us at 574-825-9679 and choose the "Recall" prompt or email [recall@granddesignrv.com](mailto:recall@granddesignrv.com). We can discuss other arrangements to have the needed inspection & repairs completed.
