Dear Mercedes-Benz Metris Owner:

This notice is being sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Mercedes-Benz AG ("MBAG"), the manufacturer of Metris vans, has decided that a defect which relates to motor vehicle safety exists in certain Model Year ("MY") 2017-2022 Mercedes-Benz Metris vehicles. Our records indicate that your vehicle is included in the affected population of vehicles.

What is the issue?



MBAG has determined that on certain Mercedes-Benz Metris vehicles, the upper and lower fuel hose connections for the fuel lines on the 4-cylinder engines may not be securely attached. This could possibly lead to minor fuel leakage at the upper connection that feeds the high-pressure fuel pump, or at the lower connecting point of the transition hose between the underbody fuel line and the Schrader valve. Fuel leakage in the presence of a potential ignition source within the engine compartment could create the risk of a fire.



What will your Mercedes-Benz Dealer do?

An authorized Mercedes-Benz Metris dealer will check the correct mounting of the upper and lower fuel hose connections and replace the clamps and the fuel hose if necessary. This could take approximately 1 hour.

This service will be provided **free of charge**. You may be asked for your 17-digit Vehicle Identification Number (VIN) which for your convenience is located above your name at the top of this letter.

Reimbursement to Customers for Repairs Performed Prior to Recall

If you have already paid to have this recall condition corrected, you may be eligible to receive reimbursement. Requests for reimbursement may include parts, labor, fees and taxes. The following documentation must be presented to your dealer for reimbursement.

Original or clear copy of all receipts, invoices and/or repair orders that show:

- The name and address of the person who paid for the repair.
- The Vehicle Identification Number (VIN) of the vehicle that was repaired.
- What problem occurred, what repair was done, when it was done and who repaired it.
- The total cost of the repair expense that is being claimed.
- Proof of payment of repair (copy of front and back of cancelled check or copy of credit card receipt).
- Reimbursement will be made by check from your dealer. If your claim is denied you will receive a letter from MBUSA within 60 days of receipt with the reason(s) for the denial.
