## **IMPORTANT SAFETY RECALL – NHTSA Recall No. 22V-220**

**This notice applies to Your Lamborghini Huracan EVO or Lamborghini Huracan STO with the VIN**

Dear Lamborghini Owner or Lessee,

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act. As a result of the continuous product monitoring, Automobili Lamborghini S.p.A. has determined that a potential defect, which relates to motor vehicle safety exists in Huracan EVO model year 2020 and Huracan STO model year 2022 vehicles.

Our records indicate that you are the owner of a vehicle in this recall.

### **What is the issue?**

It has been determined that the subject vehicles gearbox oil quantity may be too low due to a supplier mistake and could potentially lead to short-term hydraulic pressure drop resulting in clutch slippage. Also, in extreme driving situations (racetrack operation), the transmission oil can foam and leak out of the gear vent. If leaked transmission oil contacts hot exhaust system parts, there is a possible risk of fire.

For all the reasons set forth above, it is therefore necessary to repair these vehicles. If you are not the only driver of this vehicle, please advise all other drivers and passengers of this important information.

### **What Do You Need to Do?**

Please contact your preferred authorized Lamborghini dealer immediately to schedule an appointment to have this important repair performed, free of charge.

We will check the oil level within the gearbox and correct it free of charge. The repair could take up to 1 (one) hour. We apologize for any inconvenience this recall may cause.

Please bring this letter and your Service Booklet with you when you visit the dealer, so that the dealer can make all necessary entries.

**What if you are not the current owner of this vehicle?**

You can update your vehicle ownership and contact information by completing the enclosed document (Appendix A) and sending it to Lamborghini.

**If you are a vehicle lessor, Federal Regulations require you to forward this notice to your lessee within ten days.**
