## Dear «Owner\_name»:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act. KZRV has decided that a defect which relates to motor vehicle safety exists in certain 2021 and 2022 Connect, Sonic, Sportsmen, Sportsmen Classic, Sportsmen SE, Sportsmen Sportster, and SportTrek trailers. As a result, KZRV is conducting a safety recall. We apologize for any inconvenience this action may cause you; however, your safety and continued satisfaction are of the utmost importance to us.

Reason for this recall

The vehicles subject to this recall were built with a propane quick disconnect fitting that may be cracked or in time develop a crack. This fitting may leak propane and could result in a fire or explosion resulting in personal injury or death. This repair will be done at no cost to you.

What we will do

The remedy is to replace the quick disconnect fitting and ensure no leaks are present. The repair should take approximately 20 minutes to complete. This repair will be done at no cost to you.

What we need you to do

You should contact your selling dealer immediately to schedule a service appointment to have the defect repaired in your vehicle.
