This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act. Hyundai has decided that a defect, which relates to motor vehicle safety, exists in certain 2021 – 2022 Accent vehicles. Hyundai is initiating Recall Campaign 226, a safety recall to repair a condition involving the steering column in these vehicles in the U.S. market. Hyundai is conducting this action to ensure the safety of its vehicles for Hyundai customers. Our records indicate that your vehicle is affected by this recall campaign.

What is the problem?

The retention bolt in the steering column may not have been tightened properly. An insufficiently tightened retention bolt could result in the steering column detaching, from the steering rack. A detached steering column might cause a loss of steering control, increasing the risk of a crash.

What will Hyundai do?

Your Hyundai dealer will inspect the steering column u-joint and retighten the bolt as necessary. This procedure will be performed at **NO CHARGE** to you.

What should you do?

The actual time required to perform this procedure on your vehicle will take less than one hour, however, your vehicle may be needed longer. Therefore, we recommend scheduling a service appointment to minimize inconvenience.

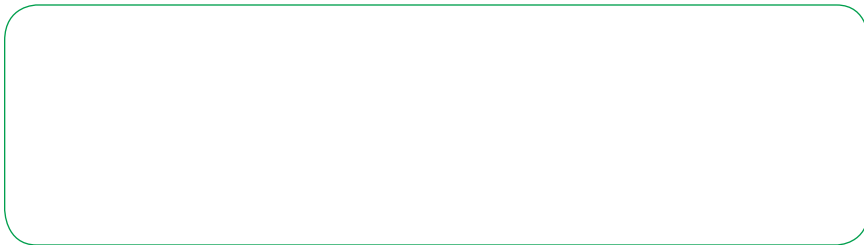
