This notice is being sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

TrailManor has decided that a defect which relates to vehicle safety, exists in certain 2021-2022 2518 series travel trailers with the Dometic 2 burner cooktop **model CE99** and **PI8022** series cooktops

Certain Dometic 2 burner cooktops may have incurred abrasions on the metal sealing surfaces of the burner control valve which may lead to leaks, increasing the risk of fire.

Take your travel trailer to a qualified Dometic rv dealer for replacement. The dealer will replace the cooktop free of charge. The repair will take approximately one to two hours. Due to scheduling the dealer may require your unit longer, he will be able to give you a more accurate timeframe.
