# **IMPORTANT SAFETY RECALL**

NHTSA Recall No. 22V-422

#### This notice applies to Your Lamborghini Huracan with the VIN

Dear Lamborghini Owner or Lessee,

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act. Automobili Lamborghini S.p.A. has decided that a defect, which relates to motor vehicle safety exists in certain Model Year 2022 Huracan EVO and STO vehicles. Our records indicate that you are the owner of a vehicle in this recall.

#### What is the issue?

It has been determined that in the subject vehicles, the driver-side door handle may not have been properly assembled which can prevent it from opening from outside of the vehicle.

It might not be possible to open the unlocked driver-side door on the by using the outside door handle, posing an entrapment risk. This failure could lead to the inability to operate the handle from outside of the vehicle which, in the event of an emergency, may increase their risk of injury. The door can be opened from inside at any time.

For all the reasons set forth above, it is therefore necessary to repair these vehicles. If you are not the only driver of this vehicle, please advise all other drivers and passengers of this important information.

#### What Do You Need to Do?

You can still drive your car, however, please contact your preferred authorized Lamborghini dealer immediately to schedule an appointment to have this important repair performed, free of charge.

### What will Lamborghini do?

We will inspect the safety clip positioning and correct it, as necessary, free of charge. The repair could take up to 1 (one) hour. We apologize for any inconvenience this recall may cause.

Automobili Lamborghini America LLC Please bring this letter and your Service Booklet with you when you visit the dealer, so that the dealer can make all necessary entries.

Lamborghini will not offer a reimbursement plan for this campaign as all involved vehicles are new and would be covered under the manufacturer's warranty program.

#### What if you are not the current owner of this vehicle?

You can update your vehicle ownership or contact information by filling out the enclosed document (Appendix A) and sending it to Lamborghini by following the instructions.

If you are a vehicle lessor, Federal Regulations require you to forward this notice to your lessee within ten days.
