**Reason for
this recall**

The vehicles subject to this recall were built with an incorrect tire placard label. The inflation values on this label are too high and if followed will result in overinflated tires which may result in a tire explosion that causes property damage, personal injury or death. This repair will be done at no cost to you.

**What we
will do**

The remedy is to replace the tire placard label. The repair should take approximately 10 minutes to complete. This repair will be done at no cost to you.

**What we need
you to do**

You should contact your selling dealer immediately to schedule a service appointment to have the defect repaired in your vehicle.
