This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Ferrari has decided that a defect which relates to motor vehicle safety exists in certain Model Year 2019 - 2022 Ferrari Portofino vehicles. The vehicles involved are equipped with a brake reservoir fluid cap that may not vent properly. This could potentially result in the leaking of brake fluid, which may lead to a partial or a total loss of braking capability, increasing the risk of a crash. We want to assure you that your safety is our priority, and we are committed to correcting this condition in your vehicle if it exists.

Our records show that you are the owner of a vehicle affected by this recall.

IMPORTANT

THE REPLACEMENT PART IS NOW AVAILABLE; PLEASE CONTACT YOUR AUTHORIZED FERRARI DEALER TO SCHEDULE YOUR REPAIR. Ferrari will repair your vehicle free of charge. The repair consists of replacing the brake fluid reservoir cap and updating the software in your vehicle to provide for a different warning message if your vehicle should lose sufficient brake fluid. The time needed for the repair and software update is estimated to be approximately 1 hour.

In the meantime, if a message appears on your dashboard, "Brake fluid level low, Go to dealer slowly", please pull off the road as soon as it is safe to do so. Then contact Ferrari Roadside Assistance at 1.866.788.6760. Your car will be taken to the nearest authorized Ferrari dealer and inspected free of charge. If necessary, Ferrari will perform any necessary repairs to your vehicle for free.

Note: The vehicle's electric parking brake can be used as an emergency brake when the vehicle is in motion. See your Owner's Manual for further information.

Your authorized Ferrari dealer will provide you with a Proof of Correction Certificate after the recall repair has been performed.
