Dear Mercedes-Benz Owner:

This notice is being sent to you in accordance with the National Traffic and Motor Vehicle Safety Act. Mercedes-Benz AG ("MBAG"), the manufacturer of Mercedes-Benz vehicles, has decided that a defect which relates to motor vehicle safety exists in certain model year 2020-2022 GLS-Class vehicles. Our records indicate that your vehicle is included in the affected population.



What is the issue?

The locking mechanism on the third-row seatbacks may fail in the event of a crash. A seat with a seatback lock failure may not properly restrain occupants, which could increase the risk of injury during a crash.



What will your Mercedes-Benz Dealership do?

An authorized Mercedes-Benz dealer will inspect and replace the third-row seatback, if necessary. **This vehicle repair will be provided at no cost to you.** While the minimum repair time can be less than 30 minutes, your dealership can provide you with a better estimate of the overall time for this service visit. As a matter of normal service process, an authorized Mercedes-Benz dealer will also check for other repair measures which might be applicable to your vehicle and this may increase the required working time. You will not be charged for other service or repairs unless so requested.



Steps to take.

- Find your nearest authorized Mercedes-Benz dealership at mbusa.com/recalls to schedule your recall repair.
- Please mention you are scheduling an appointment for Mercedes-Benz Recall Campaign 2022100011.
- You may be asked for your VIN, which for your convenience is located at the top of this letter.
