This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Volvo Car USA LLC on behalf of Volvo Car Group, have decided that a defect, which relates to motor vehicle safety, exists in certain model year 2022-2023 60 series and 90 series long range PHEV vehicles.

The reason for Recall R10198:

An electronic control module (ECM) software error may prevent the combustion engine from starting, causing loss of power to the wheels increasing the risk of a crash.

Recall action: R10198:

The corrective action is to perform a Software Upgrade, free of charge.

The release of this software will not be available via over-the-air (OTA) for your vehicle until mid-December. However, you can still have this software upgrade performed at your authorized Volvo retailer. Please contact your authorized Volvo retailer to schedule an appointment for the repair to be completed. This procedure will be completed at **no cost** and can take up to one hour to complete, however due to service scheduling your Volvo retailer may require your vehicle for a longer period.
