

# **IMPORTANT SAFETY RECALL**

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Brenner Tank has decided that a defect, which relates to motor vehicle safety, exists in certain 2020-2021 model year Brenner Tank vehicles.

## **Description of Defect**

The steer arm on the IMT lift axle has potential to fail.

### **<u>Risk to Motor Vehicle Safety:</u>**

The fractured steer arm and tie rod can separate and fall to the ground, increasing the risk of crash or injury.

## **Precautions You Should Take:**

Make immediate arrangements with a Dexter authorized service facility to replace the steer arms.

## **Remedy:**

Enclosed with this notification is Safety Bulletin "#SB015". The equipment listed within, should be inspected, and remedied per the instructions described in bulletin #SB015. This repair should take approximately 6 hours and will be performed at no cost to the owner. The owner may perform this recall and be reimbursed by Dexter Trailer Products of Canada Corporation.
