Dear Mercedes-Benz Owner:

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Mercedes-Benz AG (“MBAG”), the manufacturer of Mercedes-Benz vehicles, has decided that a defect which relates to motor vehicle safety exists in certain model year (“MY”) 2022 AMG G63 4x4 squared vehicles. **Our records indicate that your vehicle is included in the affected population.**



### What is the issue?

The rear axle differential housing might crack. This might lead to differential oil leaking onto the roadway which could increase the risk of a crash for following vehicular traffic. Furthermore, the rear axle differential housing could break, which could lead to a loss of rear wheel control and/or a loss of drive power without warning, which could increase the risk of a crash or injury.

**Your vehicle is not safe to drive until a repair is performed. Please stop driving your vehicle immediately! If necessary, the vehicle can be towed, free of charge to an authorized Mercedes-Benz dealership and a loaner vehicle can be provided, if available.**

### What will your Mercedes-Benz Dealership do?

An authorized Mercedes-Benz dealership will replace the rear axle differential. **This vehicle repair will be provided at no cost to you.** While the minimum repair time can be 10 hours, your dealership can provide you with a better estimate of the overall time for this service visit. As a matter of normal service process, the authorized Mercedes-Benz dealership will check for other repair measures that might be applicable to your vehicle, which may increase the required working time. You will not be charged for other service or repairs unless so requested.



### Steps to take.

- Find your nearest authorized Mercedes-Benz dealership at [mbusa.com/recall](https://mbusa.com/recall) to schedule your recall repair.
- Please mention you are scheduling an appointment for Mercedes-Benz Recall Campaign **2023040001**.
- You may be asked for your VIN, which for your convenience is located at the top of this letter.
