This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act. Renegade RV has decided that a defect, which relates to motor vehicle safety, exists in certain 2022/2023 Valencia vehicles.

**What is the issue:** According to the defect information report filed by the supplier of the service valves, Engineered Controls International, LLC (NHTSA No. 22E-058), for certain service valves, the thread depth of the POL (Prest-O Lite) outlet is less than specification, which could result in a leak of propane.

**What is the safety risk:** A leak in an enclosed area in the presence of an ignition source could lead to a fire, and in some circumstances, tank ruptures. Manchester Tank is not aware of any reports of fire or injury related to the subject service valves.

**Identify any warning which can precede or occur:** Leaking valves may be detected by smell, sound, or loss of propane.

**What is the cause:** According to Engineered Controls International, a tool change in Feb. 2021 resulted in an incorrect thread depth for a limited production run of valves.

**What is the Remedy: At no cost to the customer,** Upon receipt of this notice contact your local service center to schedule an appointment to have the inspection or remedy performed. Renegade RV will execute this remedy (0.5 labor hours allotted for inspection of valve, 2.0 hours for replacement of valve). For tanks or valves, Manchester Tank will provide instructions

for inspecting the tank valves to ensure there are no leaks. For tanks with valves that leak, Manchester Tank will work with its supplier and the RV manufacturers to replace defective service valves at **NO CHARGE** to the customer.

If you have incurred expense to remedy this issue prior to the date of this notice, you may have the opportunity to obtain reimbursement for that expense. For details, contact us at the email address provided.
