Dear Mercedes-Benz Owner:

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act. Our most recent records indicate that the Mercedes-Benz vehicle registered in your name is affected by the subject recall, and still has not been repaired. We want to stress the importance of making an appointment at your preferred authorized Mercedes-Benz dealer as soon as possible for this FREE recall repair. The original communication for this recall was sent to the owner who was on file as of May 2022.

Mercedes-Benz AG ("MBAG"), the manufacturer of Mercedes-Benz vehicles, has decided that a defect which relates to motor vehicle safety exists in certain model year 2021-2022 Maybach S-Class vehicles. **Our records indicate that your vehicle is included in the affected population.**

### What is the issue?



The front seat back trim might detach during rear airbag deployment, which could damage the airbag cushions or cause the front passenger airbag, driver seat belt, and front passenger seat belt to deploy improperly. Improper airbag or seat belt deployment could increase the risk of injury for the occupants.

### What will your Mercedes-Benz Dealer do?



An authorized Mercedes-Benz dealer will replace the front seat back trim on the affected vehicles. **This vehicle repair will be provided at no cost to you.** While the repair time can be less than **8 hours**, your dealer can provide you with a better estimate of the overall time for this visit. As a matter of normal service process, the authorized Mercedes-Benz dealer will also check for other repair measures that might be applicable to your vehicle, which may increase the required working time. You will not be charged for other services or repairs unless so requested.
