Dear Mercedes-Benz Owner:

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act. Our most recent records indicate that the Mercedes-Benz vehicle registered in your name is affected by the subject recall, and still has not been repaired. We want to stress the importance of making an appointment at your preferred authorized Mercedes-Benz dealer as soon as possible for this FREE recall repair. The original communication for this recall was sent to the owner who was on file as of February 2023.

Mercedes-Benz AG (“MBAG”), the manufacturer of Mercedes-Benz vehicles, has decided that a defect which relates to motor vehicle safety exists in certain model year (“MY”) 2012–2020 GLE/ML and GLE Coupe vehicles. **Our records indicate that your vehicle is included in the affected population.**

### What is the issue?



Water might accumulate in the spare tire wheel well and damage the fuel pump control unit, which could cause an engine stall while driving. An engine stall while driving could increase the risk of a crash.

### What will your Mercedes-Benz dealer do?



An authorized Mercedes-Benz dealer will install a water drain plug, inspect for water intrusion, and replace the fuel pump control unit, if necessary. **This vehicle repair will be provided at no cost to you.** While the repair time can range from 1-5 hours, your dealer can provide you with a better estimate of the overall time for this visit. As a matter of normal service process, the authorized Mercedes-Benz dealer will also check for other repair measures that might be applicable to your vehicle, which may increase the required working time. You will not be charged for other service or repairs unless so requested.

### Steps to take.



- Find your nearest authorized Mercedes-Benz dealer at [www.mbusa.com/recall](http://www.mbusa.com/recall) to schedule your recall repair.
- Please mention you are scheduling an appointment for Mercedes-Benz recall **2023010002** or **2023010003**.
- You may be asked for your VIN, which for your convenience is located at the top of this letter.

**FOR CALIFORNIA ONLY:** A Proof of Correction certificate shall be issued to you by the dealer showing that the vehicle has been repaired under this Recall Campaign. This certificate may be required by the CA Department of Motor Vehicles for vehicle registration or operation.

We apologize for any inconvenience this may have caused and look forward to taking care of this important safety recall immediately.

### Reimbursement to Customers for Repairs Performed Prior to Recall

If you have already paid to have this recall repair completed, you may be eligible to receive reimbursement. Requests for reimbursement may include parts, labor, fees and taxes. Reimbursement may be limited to the amount the repair would have cost if completed by an authorized Mercedes-Benz dealer. The following documentation must be presented to your dealer for reimbursement.

Original or clear copy of all receipts, invoices and/or repair orders that show:

- The name and address of the person who paid for the repair.
- The Vehicle Identification Number (VIN) of the vehicle that was repaired.
- What problem occurred, what repair was done, when it was done and who repaired it.
- The total cost of the repair expense that is being claimed.
- Proof of payment of repair (copy of front and back of cancelled check, or copy of credit card receipt).
- Reimbursement will be made by check from your dealer.
