### PROCEDURE



Park vehicle safely, apply parking brake, stop the engine. Prior to working on the vehicle, set the ignition switch to the OFF position and trip the main circuit breakers equipped with a trip button. On Commuter type vehicles, set the battery master switch (master cut-out) to the OFF position.

Lockout & Tag out (LOTO) must be performed during set-up, maintenance or repair activities. Refer to your local procedure for detailed information regarding the control of hazardous energy.

#### FOREWORDS

1. The farebox and the driver barrier do not need to be removed to perform the driver seat replacement.

#### PREPARATION

Drain the air from the Accessories tank. This tank is found above the secondary air tank. It is provided with a bottom drain valve.

3. Close the drain valve once done.

4. In the front service compartment, disconnect the driver seat harness.



5. Under the driver seat, disconnect the air supply line.

6. Unscrew and remove 6 screws attaching the seat to the riser (3 screws per side). Note if torque seal marks are present.

7. With the help of an assistant, pull the seat out of the bus.

8. Replace the 2 backplates securing the riser with the long bar supplied with the new seat.

### MODIFICATION TO THE AISLE STAIRS COVER

9. Remove the aisle stairs cover and cut a part of it as shown.

Dimensions to cut: about 10 mm X 30 mm

10. Cut fiberglass on the stairs as shown. The goal is to reinstall the cover as far as possible towards the entrance door so to leave a greater clearance between the seat and the cover.

# SEAT INSTALLATION

11. Reinstall the cover as far as possible towards the entrance door. Take note that the cover is now over the step and lean on the edge of the aluminum molding.





12. Record the serial number of the new seat and the VIN of the vehicle in which it is installed.

13. Before moving the new seat in the vehicle, relocate the stopper screw to the second hole (right rail, curb side, at the back of the seat).

14. <u>With the help of an assistant</u>, install the new seat on the riser with the 6 screws previously removed. For aesthetic consideration, apply torque seal marks only if torque seal marks were present on the previous installation.

15. Under the seat, connect the seat air supply line from the push-in fitting.





16. In the front service compartment, connect the driver seat harness, red, black and Open.





17. Check fit and function. No interference around the seat in the full back and forth range.

18. Sit on the seat with the parking brake off. Stand off the seat. You should hear " Parking brake off " from the clever device unit.
