2019 – 2022 Accent, 2021 – 2023 Elantra, and 2021 – 2022 Elantra HEV Seat Belt Pretensioner

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act. Hyundai has decided that a defect, which relates to motor vehicle safety, exists in certain 2019 – 2022 model year Accent, 2021 – 2023 Elantra, and 2021 – 2022 model year Elantra HEV vehicles. Your vehicle, with the VIN shown above, is among the impact vehicles. Hyundai is initiating a safety recall to repair a condition involving the seat belt pretensioners in the U.S. and Canada.

The purpose of this letter is to explain what the recall is about and to keep you informed of Hyundai's recall implementation plan. We are currently preparing to implement the safety recall remedy which when available, will be performed at no cost to you. We will send you another notification when the remedy is available.

What is the problem?

The front and/or passenger-side seat belt pretensioners in the subject vehicles were installed from a suspect production lot containing pyrotechnic-type pretensioners that may deploy abnormally during a crash. An abnormal pyrotechnic pretensioner deployment could cause the pretensioner to explode and project metal fragments into the vehicle occupant compartment, which may result in injury to vehicle occupants.

What should you do in the interim?

We appreciate your patience. Hyundai is currently preparing to implement the recall remedy. You will receive a second notification letter when the remedy is available. For updated information regarding this recall, please visit:
