# INTERIM NOTICE

November 11, 2022

Dear Kia Sorento/Sorento HEV/Sorento PHEV Vehicle Owner:

#### Kia has identified a defect in your vehicle which relates to motor vehicle safety.

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act. Kia America, Inc. has decided that a defect which relates to motor vehicle safety exists in certain 2021-2023 MY Sorento and Sorento HEV/PHEV vehicles equipped with a Genuine Kia tow hitch harness accessory. The defect can cause a fire, increasing the risk of injury. Our records indicate that you own or lease one of the potentially affected vehicles.

This is only an interim letter as we work on a remedy. The purpose of this letter is to keep you informed of Kia's recall implementation plan. We will send you another letter when a remedy is available so that you can schedule a dealer appointment to have the repair performed free of charge at no cost to you. IN THE MEANTIME, PLEASE SEE THE "WHAT SHOULD YOU DO IN THE INTERIM" SECTION BELOW.

#### What Is The Problem?

A fire may occur in the area of the tow hitch harness module <u>while driving or while the vehicle is parked with the ignition off.</u> Debris and moisture contamination on the tow hitch harness module printed circuit board (PCB) may cause an electrical short circuit, increasing the risk of a fire. A fire increases the risk of injury.

#### What Should You Do In The Interim?

- Park your vehicle outdoors and away from other vehicles or structures until you have this recall performed.

## Have You Changed Your Address Or Sold Your Kia?

#### What If You Are A Vehicle Lessor?

Federal regulation requires that any vehicle lessor receiving this recall notice must forward a copy of this notice to the lessee within ten days.

QR Code Use:

<sup>•</sup> A QR Code is a square, 2-dimensional barcode that can be read by mobile devices loaded with an appropriate barcode or **QR Code Reader App**. The app reads the barcode image and then launches/uploads the specific information the code contains, such as URLs, text, photos, videos.

<sup>•</sup> With a mobile device, download a QR Code Reader App. With many devices, you can do this through an app store or marketplace.

<sup>•</sup> Open the QR Code Reader App on your mobile device. The app will utilize your device's camera. Center the code in the camera viewing area. With some apps, the URL or other information will automatically load when the code is recognized. For others, you may have to snap or take a picture of the QR code.
