This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Daimler Truck North America LLC (DTNA), on behalf of its wholly owned subsidiary, Thomas Built Buses, has decided that certain 2011-2023 Thomas Built EFX and HDX school buses manufactured March 1, 2010, through August 1, 2022 fail to conform to Federal Motor Vehicle Safety Standard No. 221, School Bus Body Joint Strength.

The roof exterior joint was manufactured with insufficient strength may separate during a crash and could increase the risk of injury in the event of a crash.

This is the first of two notices you will receive regarding this subject. This letter is to inform you of an upcoming Recall to correct the issue noted above. Daimler Truck is currently securing replacement parts. **There is no action for you to take at this time**.

The second notice will inform you when the final, free remedy is available. **When you receive the second notice**, please contact your authorized Daimler Truck North America dealer to schedule the Recall for your vehicle.

If you do not own the vehicle that corresponds to the identification number(s) which appears on the Recall Notification, please return the notification to the Warranty Campaigns Department with any information you can furnish that will assist us in locating the present owner.
