Subject: Seat Belt Assembly Malfunction

This letter serves to acknowledge TOKAI RIKA Co LTD's notification to the National Highway Traffic Safety Administration (NHTSA) of a safety recall which will be conducted pursuant to Federal law for the product(s) listed below. ### **Problem Description:**

Tokai Rika Co LTD (Tokai Rika) is recalling certain front-seat outer right-side seat belt assemblies. Please see the recall report for a complete list of affected part numbers. The seat belt assembly force-limiter may not operate correctly, allowing the seat belt to extend further than intended after locking.

#### **Consequence:**

A seat belt assembly that extends further than intended may not properly restrain an occupant during a crash, increasing the risk of injury.

#### **Remedy:**

Vehicle manufacturers will inspect, and if necessary, replace the seat belt assembly, free of charge. The manufacturer has not yet provided a schedule for recall notification. Toyota owners should contact Toyota customer service at 1-800-331-4331. Subaru owners should contact Subaru customer service at 1-844-373-6614.

Please be reminded of the following requirements:

Copies of all notices, bulletins, dealer notifications, and other communications that relate to this recall, including a copy of the final owner notification letter and any subsequent owner follow-up notification letter(s), are required to be submitted to this office no later than 5 days after they are originally sent (if they are sent to more than one manufacturer, distributor, dealer, or purchaser/owner).

Please be reminded that under 49 U.S.C. § 30112(a)(3), it is illegal for a manufacturer, to sell, offer for sale, import, or introduce or deliver into interstate commerce, a motor vehicle or item of motor vehicle equipment that contains a safety defect once the manufacturer has notified NHTSA about that safety defect. This prohibition does not apply once the motor vehicle or motor vehicle equipment has been remedied according to the manufacturer's instructions.

As stated in Part 573.7, submission of the first of eight consecutive quarterly status reports is required within one month after the close of the calendar quarter in which notification to purchasers occurs. Therefore, the first quarterly report will be due on, or before, 30 days after the close of the calendar quarter.
