Subject: Generator Set Fuel Hose May Cause Gas Leak

This letter serves to acknowledge Adaptive Mobility Systems Inc's notification to the National Highway Traffic Safety Administration (NHTSA) of a safety recall which will be conducted pursuant to Federal law for the product(s) listed below. Problem Description:

Adaptive Mobility Systems Inc. is recalling certain 2020-2023 Maxvan Pathway and 2021 Maxvan Route vehicles, equipped with certain Cummins Onan QG 2800i and Onan QG 28001 EVAP generator sets. The fuel hose between the inline fuel filter and the Injection Pump Module (IPM) may have inadequate clamp force, possibly resulting in a gasoline leak.

Consequence:

A gasoline leak in the presence of an ignition source may increase the risk of fire.

Remedy:

Cummins Dealers will inspect and replace the fuel hose and clamps, free of charge. Owner notification letters are expected to be mailed September 6, 2023. Owners may contact Adaptive Mobility Systems customer service at 1-844-240-8962. Adaptive Mobility Systems number for this recall is PG5215.

Please be reminded of the following requirements:

Copies of all notices, bulletins, dealer notifications, and other communications that relate to this recall, including a copy of the final owner notification letter and any subsequent owner follow-up notification letter(s), are required to be submitted to this office no later than 5 days after they are originally sent (if they are sent to more than one manufacturer, distributor, dealer, or purchaser/owner).

Please be reminded that under 49 U.S.C. § 30112(a)(3), it is illegal for a manufacturer, to sell, offer for sale, import, or introduce or deliver into interstate commerce, a motor vehicle or item of motor vehicle equipment that contains a safety defect once the manufacturer has notified NHTSA about that safety defect. This prohibition does not apply once the motor vehicle or motor vehicle equipment has been remedied according to the manufacturer's instructions.

As stated in 49 U.S.C. § 30118(f), submission of eight consecutive quarterly reports followed by three annual reports is required. As described in 573.7, submission of the first of eight consecutive quarterly status reports is required within one month after the close of the calendar quarter in which notification to purchasers occurs. Therefore, the first quarterly report will be due on, or before, 30 days after the close of the calendar quarter. The first of three consecutive annual status reports will be due on, or before, 1 year after the eighth quarterly report was submitted.
