Description of the Safety Risk: A defective entry door latch would not allow entry or exit via the door.. There

could be an increased risk of injury if the consumer attempts to exit the

vehicle in an alternative manner or if unable to exit the unit.

Description of the Cause: Supplier changed the handle design, attempting to make a more secure

attachment groove for the retaining ring, but inadvertently created a weakened

attachment point.
