Descriptive Information: Under certain circumstances, the Tire Pilot Plus (TPP) tire pressure management

system that is provided as an accessory on SAF-HOLLAND suspension systems allows all 8 tires on a trailer to lose pressure. The condition exists on suspension systems with TPP systems with electronic control units which were first sold beginning on 01DEC22. 4,906 units were sold that have the defect. Suspension systems equipped with TPP units that are controlled by a manual pressure

adjustment feature are not impacted by the defect.

This loss of pressure event occurs only on suspension systems equipped with the Tire Pilot Plus

Chronology:

The first warranty claim reported a failure date of 27APR23. 11 additional warranty claims have been received

for failures through 24MAY23. A separate report from one customer reported an additional 8 failures that were detected before the trailer went into service. On 02JUN23, SAF-HOLLAND determined that a safety defect exists.

Description of Remedy:

Description of Remedy Program: The interim corrective action is to disable the TPP system on the CBXA40 and ULX40 Suspension Systems and for fleets to manage tire pressure manually. The final corrective action will not be known until the root cause has been determined. SAF-HOLLAND will pay appropriate costs. 16JAN24:

> The remedy for NHTSA Recall 23E-045 is to: 1) replace tire hoses, 2) replace the ECU harness, and 3) update ECU programing. Replacement parts first became available 21DEC23.

How Remedy Component Differs The Interim corrective action will result in disconnected air supply hoses from Recalled Component: on all tires and at the ECU. 16JAN24: Updated tire air hoses contain a redesigned check valve that properly checks the flow of air from the tires. Updated Electronic Control Unit (ECU) programming applies trailer air pressure to the hoses for a longer duration and at a higher pressure. Updated tire hoses are accented with a yellow wrap around the outside of the hose. Electronic Control Units (ECUs) that have been reprogrammed and for which the wire harness has been replaced will have a full size, yellow decal affixed to the front of the ECU box.

Identify How/When Recall Condition Permanent corrective action for production processes will follow the root was Corrected in Production: cause determination. 16JAN24: Production of Tire Pilot Plus systems containing the defect stopped on 09JUN23. Production of the final remedy service kits began on 21DEC23. New production of Tire Pilot Plus accessories began on 21DEC23.

Recall Schedule:

Description of Recall Schedule: A customer notification letter will, after NHTSA approval, be mailed to all

sold to customers. The letter will include a service bulletin advising owners to disable the TPP System on the CBXA40 and ULX40 Suspension Systems and telling them how to do so. Once the root cause has been identified and permanent corrective action has been developed, a second

customer letter will be sent out, after NHTSA approval.
