modules. While the investigation is continuing to be conducted by and between HL Mando and Hyundai, Hyundai reported that certain vehicles equipped with ABS modules from HL Mando could leak brake fluid internally inside the HECU/ABS modules and that it could cause an electrical short over

time.

Although HL Mando has not identified a defect, HL Mando is providing this report in accordance with Part 573.3(f) in order to identify vehicle

manufacturers that received the HECU/ABS modules.
