Descriptive Information : Threshold Warning Kit PN RI32885 used with Ricon Baylift, (RISSBF3760-1R, -2R & -3R) and Mirage (F9TF; F9TH and F10XF) series Wheelchair Lifts produced between May 7, 2012 (the effective date of the threshold warning signal requirements in FMVSS 403) and 11/15/2023.

Description of Noncompliance :

Description of the Noncompliance : Ricon supplies a remotely mounted (i.e. not mounted directly to lift), Threshold Warning System Kit PN RI32885 for the lift models listed in this report. The Threshold Warning Kit uses an assembly that includes a beacon that mounts directly above the doorway where the lift operates and one that is mounted at the discretion of the vehicle manufacturer and serves as a supplemental beacon to enhance the visibility of the platform. The kit also uses a compliant audible warning signal. The light intensity of the red beacons in this kit does not comply with the minimum light requirement of 20 candelas as specified in FMVSS 403, section S6.1.4.

Description of the Safety Risk : While the beacon used in the Threshold Warning System Kit illuminate as designed and the audible warning signal operates as required, a warning beacon light that displays below the minimum level of candelas may be less
