Description of the Safety Risk: In extreme cases the fabric could detach from the coach rail and remain

attached to the awning frame. This could allow the awning to drop and extend beyond normal operation, which could cause personal injury.

Description of the Cause: Insufficient weld penetration in some areas between the fabric and the
