Descriptive Information : Ferrari has determined that a defect related to motor vehicle safety may arise in some MY 2021 - 2023 Ferrari SF90 vehicles. The issue relates to the use of child seats on M size passenger seats pursuant to FMVSS 208. In particular, in case of an accident, the deployment of an airbag of the passenger M size seat could possibly impact the child seat, thereby potentially causing abnormal body acceleration, which may lead to injuries and/or death. Ferrari has had no reports of any incidents and/or deaths as a consequence of this issue. Affected vehicles: MY 2021 – 2023 Ferrari SF90 Coupe; MY 2022 Ferrari SF90 Spider.

Description of Defect :

Description of the Defect : Ferrari has determined that a defect related to motor vehicle safety may arise in some MY 2021 - 2023 Ferrari SF90 vehicles. The issue relates to the use of child seats on M size passenger seats pursuant to FMVSS 208. In particular, in case of an accident, the deployment of an airbag of the passenger M size seat could possibly impact the child seat, thereby potentially causing abnormal body acceleration, which may lead to injuries and/or death.

Description of the Safety Risk : Upon deployment of the passenger airbag, such deployment can impact the child seat, thereby potentially causing abnormal body acceleration, which may lead to injuries and/or death to the vehicle passenger.

Description of the Cause : Passenger seats size M installed on SF90 model (where equipped with child seats) do not comply with FMVSS 208.

Description of Remedy :

Description of Remedy Program : The repair consists of replacing the M size passenger seat with an XL size passenger seat. Ferrari will send a notice letter to all affected vehicle owners to warn them of this issue, and instruct them 1) to contact an authorized Ferrari dealer to schedule the free recall repair, and 2) that in the meantime, request them not to use/install any child seats on board of the vehicles.

How Remedy Component Differs from Recalled Component : The size of the passenger seats that will be upgraded to XL size.

Identify How/When Recall Condition was Corrected in Production : All SF90 vehicles currently in production have been fitted with XL size passenger seats starting from February 21, 2023.

Recall Schedule :

Description of Recall Schedule : The client notification letter will be sent to all known current owners of the affected vehicles advising them to contact an authorized Ferrari dealer to schedule an appointment to have the recall work performed. The letters are scheduled to be sent on or before July 15, 2023. The interim letter was sent to affected owners on April 13, 2023 and a dealer notification bulletin was published on April 21, 2023.
