Chronology :

We received a letter from Dometic Corporation stating that they would be recalling a cooktop unit. There was a concern about the burner control valve on the cooktop unit. There have been no warranty claims, field reports, death, injury or accidents

Description of Remedy :

Description of Remedy Program : Dometic Corporation has taken back all affected units that were not installed in our trailers. They have credited Eveland's Inc for those units. Dometic will be responsible for reimbursement of all trailers that will need the affected cooktop removed. Dometic has resolved the manufacturing issue by removing all compromised burner valves from their assembly line.

How Remedy Component Differs from Recalled Component : The remedied component will look identical to the recalled component. The new component will not have the damaged burner control valve.

Identify How/When Recall Condition was Corrected in Production : When Eveland's Inc received the recall letter from Dometic we removed all affected cooktop units from production. Any trailer that was built with an affected cooktop unit had the recalled unit removed.
