Description of the Defect :	Warn Industries has decided that a defect which relates to motor vehicle safety exits in the handheld remote control device that was sold with WARN VR EVO winches. A small number of remotes which have been exposed to or submerged in water have exhibited failures that can result in unintended winch operation. Only the remote is subject to recall. The winch is not affected.

Description of the Safety Risk :	Water may enter the handheld remote control for the winch and cause circuit board corrosion, which can allow the winch to operate unintentionally, increasing the risk of injury.

	The initial remedy involved removing the battery pack which is the failing component from the remote. The secondary remedy being issued by WARN will involve shipping a new water resistant designed remote.
